The Pricing, Data Analysis, and Coding (PDAC) Contractor provides Healthcare Common Procedural Coding System (HCPCS) assistance to manufacturers to ensure proper coding of Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS). The PDAC has reviewed the above listed products. It is our determination that the Medicare HCPCS codes to use when billing the four Durable Medical Equipment Medicare Administrative Contractors (DME MACs) are:

XELETON ACL KNEE BRACE, XELETON CI KNEE BRACE, AND XELETON PCL KNEE BRACE

L1845 - KNEE ORTHOSIS, DOUBLE UPRIGHT, THIGH AND CALF, WITH ADJUSTABLE FLEXION AND EXTENSION JOINT (UNICENTRIC OR POLYCENTRIC), MEDIAL-LATERAL AND ROTATION CONTROL, WITH OR WITHOUT VARUS/VALGUS ADJUSTMENT, PREFABRICATED, INCLUDES FITTING AND ADJUSTMENT

COTTON LYCRA SUSPENSION SLEEVE L2397 - ADDITION TO LOWER EXTREMITY ORTHOSIS, SUSPENSION SLEEVE

XELETON PROTECTIVE COVER A9270 - NON-COVERED ITEM OR SERVICE

L2999 was not assigned because the product is considered a convenience item and not medically necessary. According to the Local Coverage Determination for Knee Orothosis (L27058) addition codes may be separately payable if:

- 1. They are provided with the related base code orthosis; and
- 2. The base orthosis is reasonable and necessary; and
- 3. The addition is reasonable and necessary.

Addition codes will be denied as not reasonable and necessary if the base orthosis is not reasonable and necessary or the addition is not reasonable and necessary.

The PDAC provides coding decisions based on the coding guidelines established by the Local Coverage Determination (LCD) and associated policy article developed by the DME MACs. All products submitted to PDAC for a coding verification review are carefully examined by coders and professionals following a formal, standardized process.

This decision applies to the application that we received on August 24, 2011. If information submitted in that application has changed or were to change, it could impact our decision. Therefore, a new application would need to be submitted for HCPCS coding verification review. This coding decision will be available within ten (10) working days on the Durable Medical Equipment Coding System (DMECS), which is located on the PDAC web site, www.dmepdac.com. Please take the time to verify that this coding decision is correctly reflected in DMECS.

It is the responsibility of manufacturers and distributors to notify the PDAC immediately of any changes involving their products, related to their current listing on the Product Classification List (PCL) on DMECS.
